U.S. Surgeon General Visits FMC Butner

On January 27, FMC Butner hosted a visit by United States Surgeon General, Dr. Regina M. Benjamin. Dr. Benjamin was accompanied by Rear Admiral (RADM) Dr. Newton E. Kendig, Assistant Director (AD), Health Services Division; and RADM William S. Stokes, Director of the National Toxicology Program Interagency Center of Alternative Toxicology Methods

at the National Institute of Environmental Health Science in North Carolina. FCC Butner Complex Warden Sara Revell and Wardens Tracy W. Johns and Angela P. Dunbar provided an overview of the Complex and discussed medical care and services provided to the inmate population. A tour of the FMC highlighted the Advanced Care Unit, Oncology Department, Hospice, and Medical Housing Units. Following the tour, Dr. Benjamin attended a staff recall and awards ceremony and commended FCC Butner staff for their hard work, dedication, and commitment to the BOP and the U.S. Public Health Service.

FCC Tucson Recycling Factory Receives R2 Certification

On January 18, Phil Sibal, Senior Deputy Assistant Director, Industries, Education, and Vocational Training, joined FCI Tucson Warden Louis W. Winn, Jr., to congratulate UNICOR's recycling factory on receiving certification under the "Responsible Recycling Practices for Electronics Recyclers" (R2) standard. FCI Tucson's recycling factory is the sixth of UNICOR's seven factories to achieve R2 certification. The factory received certification that it meets demanding standards including environmental and public health, worker health and safety, security, and chain of custody procedures, following an evaluation by a third-party auditing firm.

The fair provided an interactive and informational environment for inmates to obtain information and participate in seminars that met their individual reentry needs. Guests included The Honorable M. Volunteers from more than 25 community resource agencies participated in the reentry fair. A mobile career center was on-site for inmates who will be transferring to Residential Reentry Centers to upload their resumes into a nationwide job databank. The Montgomery Small Business Association held miniseminars on "Entrepreneurship" and "Rebuilding Your Image after Prison." Volunteers from the Society for Human Resource Management conducted practice interviews and critiqued inmate resumes. The federal judges held a question and answer session with inmates.

The volunteers and federal court staff also had the opportunity to tour the institution and view the Barbershop, Commercial Driver's License, Culinary Arts, and Dog Trainer apprenticeship programs.

FCI Sheridan

On January 19, the City of Sheridan requested assistance from FCI Sheridan to help prevent flooding damage as the Yamhill River's water level rose. Camp inmates filled 2,600 sandbags (using 40 tons of sand); the sandbags were then used at locations throughout Sheridan. As flood levels continued to rise the next day, inmates filled another 650 sandbags. When the flood waters began to recede, unused sandbags were stored for use during future emergencies. Sheridan officials and residents expressed their appreciation for the assistance provided by FCI Sheridan.
