On March 6, 2013, The Honorable Judge Frank Montalvo, US District Court Judge for the Western District of Texas, facilitated a meeting at the El Paso Federal Courthouse regarding “Project Sendero Reentry Court.” The Sendero program is four phases over a twelve month period focusing on high risk inmates with significant reentry needs. Staff from the BOP, USPO, and the Residential Reentry Center (RRC) will meet periodically with Judge Montalvo to monitor the program. The principal goals of the program are to reduce recidivism and promote successful community reintegration while maintaining public safety. Participating inmates may receive incentives such as a reduction in their supervised release time, if they successfully complete the program.
