# In Memoriam: Retired Assistant Director Bruce Sasser

On March 30, Bruce Sasser, retired Assistant Director, Administration Division, passed away following heart surgery. He was 62 years old. Mr. Sasser, who had a 37 year government career, served as the Bureau's Assistant Director for Administration and Chief Financial Officer from 1999 until his retirement in January 2008.

Mr. Sasser began his government career with the National Park Service while he was in college. After graduating, he was selected for a management intern program with the General Services Administration's Public Buildings Service. He then joined the Office of Management and Budget (OMB), and later served as Director of the Office of Policy and Programs in the U.S. Department of State's Bureau of Refugee Program. From 1986 until 1999, Mr. Sasser served as Chief of the State-USIA Branch in OMB's International Affairs Division.

During Mr. Sasser's tenure as Assistant Director, the Bureau added 28 new institutions, along with 18,000 contract beds; the agency's budget grew from \$2.8 billion in FY 1999 to \$5.1 billion in FY 2008. Under Mr. Sasser's leadership, the Bureau received Unqualified (clean) Opinions on its audited financial statements for nine consecutive years—the best record in the Department of Justice. During his career, Mr. Sasser received a number of awards, including the OMB Professional Achievement Award, the Secretary of State's Superior Honor Award, and the Presidential Rank Award for Meritorious Service.
