# **USP McCreary holds leadership** training graduation

On March 13, 2013, USP McCreary held its first Leadership Enhancement and Development Program (LEAD) graduation ceremony for 12 staff members who completed the 10-month program. Several institution and community leaders were LEAD instructors. The program addressed a variety of leadership principles and also included modules such as 360 Degree Leadership Assessment, Situational Leadership, No Excuses, and team building. 10-months During the of training, participants visited the offices of several community partners and attended a court hearing presided over by The Honorable Gregory Van Tatenhove, U.S. District Court Judge for the Eastern District of Kentucky.

# FCC Coleman-Low hosts reentry marriage training

On April 2, 2013, the Religious Services Department at FCC Coleman-Low hosted a reentry marriage training course, called "Breaking the Chains: Transitioning and Reconnecting in Marriage," for 15 inmates and their wives. Chaplain Harris, Chaplain

Bass-Garcia, and Tonya Crane, Re-entry Affairs Coordinator, led the five-hour program on how to reintegrate back into the household and how to effectively communicate while re-establishing marriage and family ties. The class provides helpful life management skills and inmates with 36 months or less remaining of their sentence have priority placement consideration. Based on the positive feedback, the course will also be offered at the other facilities at FCC Coleman.

# MDC Brooklyn hosts reentry documentary screening

On April 10, 2013, MDC Brooklyn hosted a screening of the documentary short "The Long Shadow of Incarceration's Stigma". This film follows two formerly incarcerated individuals and highlights the struggles of reentering society. The screening was followed by a panel discussion with Sheila Rule, founder of Think Outside the Cell Foundation; Ron Haviv, Photojournalist; and Ronald Day and Mercedes Smith, who were subjects of the documentary. The event was coordinated by Erin Rogers, Reentry Affairs Coordinator and Dr. Michelle Gantt, Supervisor of Education. Approximately 115 inmates and 15 staff participated.

The film makers, in conjunction with the Think Outside the Cell Foundation, plan to create a series of documentary shorts that will bring awareness of the difficulties inmates face when they reenter society.

# FCI La Tuna holds local gang intelligence meeting

On April 11, 2013, staff from FCI La Tuna and the El Paso Residential Reentry Office hosted the local gang intelligence meeting for the High Intensity Drug Trafficking Area (HIDTA) program. Warden Rachel Chapa welcomed approximately fifty representatives from the following agencies: U.S. Probation, Texas Department of Criminal Justice, Federal Bureau of Investigation, Immigration and Customs Enforcement, Department of Homeland Security, Drug Enforcement Administration, El Paso Sheriff's Office, National Drug Intelligence Center, and Dismas Charities Residential Reentry Center.

The gang task force meets monthly to discuss local gang activities and share intelligence with federal, local, and state law enforcement representatives.
