Southeast Regional Director-selectee: Helen J. Marberry



Helen J. Marberry began her BOP career as a Case Manager at the Federal Correctional Institution (FCI) Otisville, NY, in 1991, and held positions of increasing responsibility at the Low Security Correctional Institution (LSCI) at the Mission of the Bureau of Prisons Federal Correctional Complex (FCC) Allenwood, PA, and the Office of Internal Affairs in Aurora, CO, before being named Associate Warden (AW) at FCI Oxford, WI, in 2000. From 2002-04, she served as AW at the United States Penitentiary (USP) Leavenworth, KS, and was then promoted to Warden at FCI Milan, MI. She also served as

Warden at FCI McKean, PA, from 2006-08. In 2008, she became the first female Complex Warden at FCC Terre Haute, IN. In that capacity, she was responsible for the confinement of more than 3,000 inmates, a workforce of 700 staff, and an annual operating budget of approximately \$96 million. She assumed her current position as Assistant Director of the Program Review

Western Regional Director-selectee: Dr. Juan D. Castillo



Dr. Juan D. Castillo began his career with the Bureau of Prisons in June 1992 as a Physician's Assistant (PA) at USP Lewisburg, PA. He was promoted to Supervisory PA at FCI Estill, SC, in 1994, and was selected as Assistant Health Systems Administrator at FCI Miami, FL, the

following year. In 1997, he was promoted to Health Systems Administrator (HSA) at FCI Miami. In 1997, Dr. Castillo became HSA at FCI Edgefield, SC.

In January 2000, Dr. Castillo was selected to serve as Deputy Chief of the Affirmative Action Programs Branch, Human Resource Management Division (HRMD), in the Central Office. He later served as Executive Assistant in HRMD. He was selected as AW

for the Federal Medical Center (FMC) Fort Worth, TX, in 2002, and from October 2004 to May 2006, was AW during the activation of FCC Terre Haute, IN. Dr. Castillo subsequently returned to HRMD in the Central Office as Deputy Assistant Director. He served as Warden at FCI Memphis, TN, from January 2008 to July 2011, at which time he became Warden for the Medical Center for Federal Prisoners (MCFP) Springfield, MO.

Dr. Castillo received his Doctorate degree in Medicine from Universidad Central Del Este (East Central University) in Santo Domingo, Dominican Republic. He has received many awards during his career, including Physician's Assistant of the Year, Supervisor of the Quarter, and South Central Region Associate Warden of the Year, as well as numerous institution special achievement and performance-based awards.

On selecting Dr. Castillo, Director Samuels stated: "I am pleased to announce that Juan Castillo will be joining the Bureau's Executive Staff as Regional Director for the Western Region. His exceptional leadership, commitment to excellence, and dedication to public service will serve the Bureau well in his new assignment. I look forward to his input and contributions as a member of the Executive Staff."

Sara M. Revell is currently the Complex Warden at FCC Butner, NC. In that capacity, she oversees the operations of five separate facilities, approximately 1,500 staff, and 5,100 inmates.

Warden Revell began her Bureau of Prisons career in 1986 as a Case

Management intern at what was then FCI Lexington, KY. She went on to hold positions of increasing responsibility at the Federal Prison Camp (FPC) Yankton, SD; FCI Marianna, FL; the Southeast

Regional Office in Atlanta, GA; and FPC Montgomery, AL. Ms. Revell served as AW at FCC Coleman, FL, and USP McCreary, KY, before being named Warden for FCI Greenville, IL, in 2005. Warden Revell transferred to the USP at FCC Florence, CO, as Warden where she served until January 2009 when she was named to her current position at FCC Butner.

Ms. Revell completed her undergraduate studies at Luther College in Decorah, IA, and attended graduate school at the University of Kentucky. She received the Bureau's Excellence in Prison Management Award in 2007. Warden Revell has given numerous presentations at BOP training conferences, as well as to civic organizations. She is currently an instructor in the Bureau's Principles of Leadership Program.

Director Samuels announced his selection of Ms. Revell by stating, "It is a pleasure to welcome Sara Revell to the Executive Staff as Assistant Director for Program Review. Her dedication to the Bureau's mission and her commitment to developing leaders within the BOP have benefitted the agency and I am confident she will continue to do great things for the agency in her new role."
