Reentry Initiative Strategy in South Carolina

On August 8, The Honorable Bill Nettles, United States Attorney, and Beth Drake, First Assistant U.S. Attorney, for the District of South Carolina, hosted a roundtable discussion to develop a reentry initiative strategy for federal offenders releasing to South Carolina. The Bureau was represented by Warden Kenny Atkinson and Reentry Affairs Coordinator (RAC) Edith Grice-Peay (FCI Edgefield); Warden Darlene Drew and RAC Jervis Steamer (FCI Bennettsville); Warden Mildred Rivera and RAC Dwight Newbould (FCI Estill); and Acting Warden Timothy Johnson and RAC David Potts (FCI Williamsburg). During the meeting, Southeast Region Reentry Affairs Administrator Myra Lowery facilitated a discussion on obstacles to successful reentry.

The meeting was a result of the Southeast Regional Reentry Executive Leadership Workshop held this past June, where attendees were challenged to discuss and develop federal reentry planning and implementation ideas for their district/state. The United States Attorney's Office, Federal Probation Offices, and the Bureau are working together to address various issues, including how to obtain proper identification for offenders releasing to South Carolina. A second meeting, to be held in September, will be hosted by FCI Edgefield.
