MCFP Springfield recently hosted its 4th annual Offender Employment Specialist training. The goal of the training was to identify tools, strategies, and best-practices for improving offender employment outcomes. The program began with opening remarks by Warden Linda Sanders, followed by a "poverty simulation exercise" facilitated by staff from the Ozarks Area Community Action Corporation (OACAC). The exercise is a tool used to educate individuals about the day-to-day reality of life with little money and a lot of stress. Representatives from the BOP, Missouri State Probation, Ozarks Correctional Center, OACAC, and other employment partners participated in the training.

Later the same day, U.S. Attorney Ihlenfeld; AUSA Flower; Law Enforcement Coordinator Gary Gaus; and ATF Resident Agent in Charge Dewayne Haddix gave a presentation titled "Project POWER" (Preventing Offenses of Weapons, Enforcement, and Reentry) to the inmate population. The purpose of the program was to enhance inmates' awareness and understanding of federal and state statutes and penalties in an effort to better prepare inmates prepare for reentry and prevent recidivism. Approximately 200 inmates nearing release attended the program.
