The Cubby Dorsey Award for Outstanding Service by a Federal Wage System Employee

The Cubby Dorsey Award for Outstanding Service by a Federal Wage Grade System Employee is designed to recognize extraordinary performance and contributions by wage grade system employees, including laborers, mechanics, and skilled craft workers. Generally, only one award will be granted each year.



Award Winner: **Tony Poppe**, Welding Worker Supervisor, USP Leavenworth

Mr. Poppe was selected for his exceptional service and outstanding achievements in designing and coordinating the construction of several structures at USP Leavenworth. His noteworthy contributions to various projects at the USP have been used by other BOP institutions, as well as the Department of

Defense and other Federal and State law enforcement agencies. In addition, Mr. Poppe works closely with the USP's Education Department, providing apprenticeships, on-the-job training, and work skills to inmates to assist in their transition back into the community. His creativity and use of alternative building materials have saved the Bureau in excess of thousands of dollars, and his skills and ingenuity are outstanding assets to the Federal Bureau of Prisons.

MDC Guaynabo Hosts HIDTA Meeting

On October 20, MDC Guaynabo hosted the Supervisor's High Intensity Drug Trafficking Area (HIDTA) meeting. Warden Jerry C. Martinez provided opening remarks and an overview of the institution, and Associate Wardens Angel G. Motta and Edwin Perez discussed their responsibilities and the departments they oversee. Special Investigative Agent Jose Rosa provided information about the institution's intelligence program and encouraged the participating agencies to continue with the exchange of information. Training Coordinator, Nelson Rohena, HIDTA provided closing remarks. Attending the meeting were representatives from the Internal Revenue Service; U.S. Marshals Service; U.S. Probation and Pre-Trial Services: U.S. Border Patrol: Immigration and Enforcement Customs Enforcement: Drug Administration; Alcohol, Tobacco and Firearms; the San Juan, Humacao, Fajardo and Juncos Municipal Police; Puerto Rico Treasury Department; and Puerto Rico Forensic Sciences.

FCC Coleman Holds **OES Training**

On October 12 and 13, FCC Coleman hosted its 3rd Annual Offender Employment Specialist (OES) Harmon, Reentry training. William **Affairs** Coordinator, provided opening remarks and discussed the goals and mission of the reentry program, and Warden Jorge L. Pastrana welcomed the participants. The first day of training focused on understanding the needs of inmates who are transitioning to the community, while the second day stressed utilizing community resources to bridge the gap. Tonya Crane, Reentry Affairs Coordinator, and John Upchurch, Mentor Coordinator, facilitated the group sessions and workshops. Representatives from local, state, and Federal agencies included: U.S. Probation and Pre-Trial Services; the U.S. Attorney's Office for the Middle District of Florida; Department of Veterans Affairs; Marion County Tax Collectors Office; College of Central Florida; Workforce Central Florida; Vocational Rehabilitation Center; Salvation Army Adult Rehabilitation Center; Marion County Faith and Justice Coalition; Abe Brown Ministries, Inc.; First Baptist Church of Leesburg; and Lake Community Action Agency. FCC Coleman reentry staff continue to foster new partnerships with other agencies.

FCI Sheridan's Agriculture and Produce Program

FCI Sheridan's Agriculture and Produce Program (APP), a collaborative effort between the Facilities, Food Service and Safety Departments, currently farms 6.5 acres of land, providing the institution with a supply of fresh seasonal produce and helping reduce the cost of food. As of October 2011, more than 110,000 pounds of produce has been harvested, allowing the institution to avoid spending approximately \$32,000 on food. The APP is a U.S. Department of Agriculture-approved apprenticeship farm worker program, providing inmates with practical job skills and training.

This year's crop included jalapeno and bell peppers, zucchini, lettuce, cucumbers, garlic, broccoli, cabbage, cauliflower, squash, corn, tomatoes, watermelon, cantaloupe, strawberries, basil, oregano and cilantro. The farm's gardening plan, developed in partnership with Oregon State University, Yamhill County Extension, highlights responsible watering practices, crop rotation, cover crops, composting and a significant reduction in the use of pesticides/herbicides by utilizing various organic initiatives.

The 2011 harvest production was five times greater than last year's yield thanks to the non-potable water resource provided by an abandoned ground water well and use of a 5,000 gallon storage tank system located at the satellite camp. The well was unused since the BOP's acquisition of the private property to build the institution in the mid-1980s. The water pump for the well is currently being fitted with one of the first solar panels produced by FCI Sheridan's UNICOR Solar Panel Factory.
