Bureau Staff Meet with Saudi Arabian Officials

On November 29, a delegation of Saudi Arabian officials met with Jack Fox, Chief, Office of Security Technology, and Carla Wilson, Executive Assistant, Information, Policy and Public Affairs Division, at the American Correctional Association's (ACA) office in Alexandria, Virginia. The Saudi group was interested in learning about the Bureau's mission, organizational structure and the use of technology in prisons. ACA is conducting a monthlong training program for the Saudi Arabian Cultural Mission; this was the fifth group of Saudi officials to meet with Bureau staff.

FMC Lexington Hosts Reentry Conference



On November 4, FMC Lexington partnered with the Bluegrass Reentry Council (BRC) to host their second annual reentry conference. Focusing on the theme, "Bridging the Gap: 180 Days is Not Enough," the conference brought together representatives from the

Kentucky Department of Corrections, Kentucky Probation and Parole, Federal Probation, Veterans Administration, faith-based and non-profit groups, one-stop centers, local jails and residential reentry centers. Warden Deborah A. Hickey welcomed the group, discussed the Bureau's reentry initiatives, and stressed the importance of establishing community partnerships. Conference topics included risk assessment, reentry case management and creating long-term reentry strategies that incorporate corrections, supervision agencies and community partners.

On December 31, 2011, FCC Victorville (Medium) Warden Tereser A. Banks will retire after more than 26 years of distinguished Bureau service. Prior to joining the Bureau, Warden Banks served with the U.S. Army for seven years. She began her BOP career as an Accounting Technician at FDC Oakdale in 1985. She went on to hold positions of increasing responsibility at MCC Chicago, MDC Los Angeles, FCI Greenville and USP Marion before becoming South Central Regional Comptroller in 1997. From 2001-2004, she served as Associate Warden at MDC Los Angeles; she also served as Associate Warden at FCC Victorville from 2004-2005. She has served as Warden at FCC Victorville (Medium) since 2005.
